Tuition

Every student at CCLS receives a generous discount from the actual cost of educating a child. St. Paul and St. Peter Lutheran Church support the building and operating costs of the school. This allows CCLS to reduce its tuition fees, not only to members of those congregations, but to everyone. The true cost of educating a student at CCLS is \$6,400.
